**Rules of the Promotional Game
“Random bonus”
(hereinafter referred to as the Rules)**

1. Organizer of the Promotional Game.

The organizer of the Promotional Game “Random bonus” (hereinafter referred to as the “Promotional Game”) is “Dzengi” Closed Joint-Stock Company (hereinafter referred to as the “Organizer”), registered in the Republic of Belarus under number 193665666, having its legal address at: Republic of Belarus, 220030 Minsk, 36-1 Internatsionalnaya str., office 625, room 2, support@dzengi.com.

2. Terms and definitions.

The terms and definitions in these Rules are used in the meanings specified in the agreements concluded between the Organizer and the participants of the Promotional Game, which terms and conditions are stated in the documents posted on the Internet at: <https://dzengi.com/ru/dogovor> (hereinafter referred to as the agreements).

3. Purpose of the Promotional Game.

Purpose of the Promotional Game is to entice new clients of the Organizer, stimulate the long-term use of the cryptoplatform (trading platform) “Dzengi.com” and the mobile application “Dzengi.com Exchange” (and its “clone” – a mobile application “Dzengi.com – Easy Investing”) in the form of versions of this software (hereinafter referred to as the “Cryptoplatform”) used by the Organizer's clients, as well as to increase the loyalty of the Organizer's clients.

4. The start and end dates of the Promotional Game.

The overall period of holding the Promotional Game, including the periods of draws, transfer of prizes and publication of the results of the Promotional Game, is from **January 27, 2025** to **February 05, 2025**.

5. Conditions under which a person becomes a participant of the Promotional Game.

5.1. A participant of the Promotional Game has to be registered (has to create an Account) on the Cryptoplatform (hereinafter referred to as the “Account”), as well as to undergo the verification procedure on the Cryptoplatform in accordance with the established procedure, and also be a client of the Organizer.

5.2. The Promotional Game is held among individuals who meet the requirements for using of the Cryptoplatform specified in Section 4 of the Terms of Use of the cryptoplatform (trading platform), other software and the website, posted on the Internet at:

5.3. A participant of the Promotional Game has to comply with these Rules, use the rights granted to him/her to participate in the Promotional Game in good faith and reasonably based on the purposes of the Promotional Game, and not to abuse these Rules and the right to participate in the Promotional Game.

5.4. A participant of the Promotional Game may not be a person who is in an employment relationship with the Organizer, the spouse of such a person, his/her close relatives, or persons who are in kinship relationships with him/her.

6. Prize fund of the Promotional Game.

6.1. The prize fund of the Promotional Game was formed from the Organizer's funds in the form of 1600 (one thousand six hundred) BYN.cx tokens, the issuer of which is the Organizer, and the value of which is 1600 (one thousand six hundred) Belarusian rubles. That being said, BYN.cx is a token representing the Belarusian ruble according to the principle: 1 such token = 1 Belarusian ruble.

6.2. The prize fund of the Organizer includes the following prizes (hereinafter referred to as the Prizes):

7. Terms of participation in the Promotional Game.

7.1. To participate in the Prize draw of the Promotional Game, its participant expresses a desire to participate in the Promotional Game by carrying out a transaction on the Cryptoplatform that starts or closes (terminates) the Leveraged transaction within the period from **January 27, 2025** to **February 02, 2025**.

7.2. Each Leveraged transaction in respect of which a participant of the Promotional Game has carried out a transaction that starts or closes (terminates) such Leveraged transaction during the period specified in sub-clause 7.1 of clause 7 of these Rules, is taken into account when drawing the prize fund.

8. The location, date, time and order of the prize fund draws, the procedure for determining the winning participants of the Promotional Game.

8.1. The prize fund draw is held at the address: Republic of Belarus, Minsk, 36-1 Internatsionalnaya str., office 625, room 2 on **February 04, 2025** at 12:00 (the start of the draw).

8.2. The prize fund draw is held openly and provides for the possibility of the participants of the Promotional Game to participate in it. To attend the prize fund draw, a participant of the Promotional Game should contact the Organizer by e-mail: support@dzengi.com during **February 03, 2025**.

8.3. For the drawing of the prize fund, a list of all Leveraged transactions is compiled, both started and closed during the period specified in clause 7 of these Rules, and each of such Leveraged transactions is assigned a six-digit number in random order starting with "000001" (hereinafter referred to as the List).

8.4. The winning numbers of Leveraged transactions are determined in several stages.

8.5. For the drawing of the prize fund, a special reel is used containing 10 (ten) opaque balls, each of which contains information on paper inside of it depicting a value from "0" (zero) to "9" (nine).

8.6. The winning number of Leveraged transactions (three numbers in total), in respect of which its initiators (participants of the Promotional Game) receive Prizes, is determined by forming them bitwise from left to right based on values contained in the numbers of balls, which are sequentially extracted from the reel.

8.7. To determine the first from the left bit of the winning number of the Leveraged transaction, balls with values from "0" (zero) to the digit corresponding to the first left value of the last sequential number of the Leveraged transaction, formed as specified in sub-clause 8.3 of this clause, are placed in the reel. Subsequently, one ball is extracted from the reel, and information about the value contained in the ball is entered into the minutes and recorded in the first from the left bit of the generated winning number of the Leveraged transaction. Next, to determine the value in each subsequent bit of the generated winning Leveraged transaction number, the balls containing information about the values that are on the List in the corresponding bit of the Leveraged transaction numbers, are loaded into the reel. Next, the balls are mixed, and one ball is extracted from the reel, and information about the value contained in this ball is entered into the minutes and recorded in the corresponding bit of the generated winning Leveraged transaction number.

8.8. The winning numbers of Leveraged transactions (three numbers in total) are determined in stages, with respect to each number separately, and in the manner specified in this clause. The first winning number of the Leveraged transaction means that the participant of the Promotional Game who initiated this Leveraged transaction receives Prize 1. The second winning number of the Leveraged transaction means that the participant of the Promotional Game who initiated this Leveraged transaction receives Prize 2. The third winning number of the Leveraged transaction means that the participant of the Promotional Game who initiated this Leveraged transaction receives Prize 3.

8.9. The persons determined in accordance with the procedure set out in sub-clause 8.8 of clause 8 of these Rules are the winners of this Promotional Game (hereinafter referred to as the Winners).

9. The procedure and timeframes of notifying about the Prizes and awarding the Prizes to the Winners.

9.1. The Organizer notifies the Winners of the Prize winnings within 1 (one) working day after the

drawing of the prize fund by sending a letter to the Winners' e-mail provided by them when concluding of the agreements.

9.2. Prizes are transferred to the Winners by crediting the appropriate number of tokens specified in clause 6 of these Rules to the Winners' Accounts on the Cryptoplatform within 1 working day after the drawing of the prize fund in accordance with the procedure provided for in these Rules.

9.3. The results of this Promotional Game are posted on the day of the prize fund draw on the Organizer's website on the global computer network Internet at the following link: <https://dzengi.com/ru/events>. At the same time, such results are posted in the form of account numbers (account identifiers (IDs)) of the Promotional Game participants (available for viewing to the participants of the Promotional Game on the Cryptoplatform), in respect of which it was determined, in accordance with the procedure provided for by these Rules, that the unique numbers of Leveraged transactions carried out by such participants are winning, and the participants who initiated them are the Winners.
